Board Meeting Minutes ZOOM MEETING 7PM 1/10/2022

Attendees: Ted Stephens, Eric Hansen, Brad Kennett, Dan Engel, Mike Garriga, Sue Garriga, Lori Bryant, Chris Hammerschmidt, Don Velcio, Greg Fife, Jim McFarland, Ed Baus, Les Checel, Keith Inniss, Walt Ellert

Announcements – Ted Stephens introduced Christ Hammerschmidt as the new Membership chair. Ted proposed and the board agreed to continue with a low-cost Zoom account on a month-to-month basis until Covid conditions change. The 2/22 board meeting will be held on Zoom. At this time, March is planned to be in-person with location data to be shared at the February meeting.

Treasurer Report – Brad Kennett reviewed the 2021 financials and current status of our checking accounts and funds at Club Registration which include commitments to Mid-Ohio for the Spring DE. Companies advertising in the newsletter have been sent invoices for 22′ – Brad predicted some fall out in advertisers and will be connecting with Glenn Kutner on this topic.

State of Ohio Non-Profit Registration – Eric Hansen reported that we need to re-institute the Non-Profit registration for the club with the state of Ohio. This will likely involve consultation with PCA national, the Office of the Secretary of State, NOR's accounting firm, and potential legal advice to complete all requirements. A review and update of the NOR By-Laws will be done in parallel with meeting state and PCA national requirements over the course of this year.

Drivers Education (DE) – Lori Bryant reported on the status of registrations for the spring and Fall DE events at Mid Oho. Both are on track to date (74 drivers registered for the Spring event and 33 for Fall). A discussion about matching a member's charitable contribution to Life Source was also held, but no decision was reached at this time pending progress on the Non-Profit Registration issues above. Mike Garriga led a discussion about a potential Labor Day weekend Nelson Ledges DE. Track rental rates are challenging and options will be explored for dealer sponsorship support, and or and inviting another PCA club to share expenses. A status update will be shared at future meetings.

New NOR Website – Greg Fife gave a presentation of the new web site and its robust capabilities. The site will require login credentials to get full access. Skip Wolfe and Greg Fife will confer on technical options for the sign-in process. The site will be going live on 1/11/22 with the same web site name- www.norpca.org.

Social Media & Newsletter – Sue Garriga and Ben Driss are working on transitioning editorship to Ben effective with the March issue with Les Checel's assistance. The Club thanks Sue for her huge contribution the past couple of years, and good luck to Ben.

2022 Event Calendar – The February board meeting will devote time to flushing out the event calendar for the year that surrounds the DE's which have locked down dates. Brad Kennett discussed re-starting the annual new member party but moving the date from traditional March to later in the spring when warmer weather could allow for an open-air event at Porsche Beachwood in consideration of Covid challenges. Update requested for the February Board meeting.

PCA NORTHERN OHIO REGION SOCIAL MEDIA POLICY GUIDELINES

5-18-2021

Purpose

The Northern Ohio Region of the Porsche Club of America (PCA) social media accounts are designed to promote activities of interest to the Regional Club membership and to further the enjoyment of PCA participation. Administrators, moderators, and participants are to remember that participation on social media is a public representation of themselves, the Northern Ohio Region, PCA and the Porsche margue.

Accounts

- All social accounts created by, for, or on behalf of the Northern Ohio Region of the Porsche Club of America are the sole property of the Region.
- All social media accounts created by, for, or on behalf of the Northern Ohio Region of the Porsche Club of America shall be transferable from one social media chair to the next.
- All passwords to social media accounts are the sole property of the Northern Ohio Region of the Porsche Club of America. Those entrusted with the passwords are considered account "administrators or moderators". Passwords should only be given to region members, upon approval by the Region Board of Directors.

Posts

- Administrators and moderators shall regularly update the Region's social media accounts.
- Participants are invited to share photos, discuss and comment on topics of general interest to PCA members, including PCA activities and Porsche cars.
- Social media accounts should not publicly post any person's private information, including home address, telephone numbers, or date of birth. All messages and postings by participants must include the full name (first and last) of the posting individual.
- The Region may establish reasonable restrictions on length, style, and frequency of messages.
- The Region social media accounts and their participants will adhere to the PCA Code of Ethics and Conduct, as follows:

THE PCA CODE OF ETHICS AND CONDUCT This document is presented to define the standards and ethics to which the organization holds itself, its elected and

appointed representatives, its employees, and its members. It supplements but does not replace our established Bylaws and procedures, which are documented elsewhere. The following represents the way we want to be and to do business.

PCA is not a political organization. It exists for the benefit of its members, to further their enjoyment of their cars. In the performance of this mandate, it must operate under the rule of law, adhering to the laws of the various countries and jurisdictions under which it exists. This means that illegal behavior is not tolerated, and that close attention is paid to the requirements of the law in the actions of all involved, national and regional officers, individual members, and those within the national office

Beyond this, we accept the obligation to do what is right. An ethical system is based on the mutual benefit of the involved parties; the corollary of this is that we treat neither fellow members nor non-members in a way that is demeaning, embarrassing, derogatory, or otherwise inappropriate. This, of course, extends to our concept of respect and equal treatment for all, regardless of gender, race, religion, national origin or other such protected status. Our natural competitiveness does not extend to taking unfair advantage of others, be they individuals, clubs, or businesses. Actions and words about which there may be some question are undertaken, when possible, only after careful thought and perhaps consultation.

Decisions affecting PCA should be either self-obvious or readily explained. Particular attention should be paid to potential conflicts of interest involving special treatment or gifts from individuals or companies possibly hoping to gain something in return. Other potential conflicts of interest, in which an officer, employee, or member must weigh his immediate and personal potential for gain against the best interests of PCA, require special thoughtful attention. Transparency in all actions is desirable. Nothing must be allowed to compromise the integrity, credibility, and best interests of PCA in the making of decisions that affect the club.

The culture of PCA is founded on doing the right thing to the best of our ability. Without this, we lose our self-respect both as an organization and as individuals, a price that we will not pay. Non-adherence to these principles will not be tolerated; behavior or actions damaging to PCA will be dealt with by the established club Bylaws and may result in permanent loss of membership.

August 2020 generated revenue of 17K; Spring DE 2021 generated revenue of 16K.





Northern Ohio Region, Porsche Club of America The History – Chapter 6 – Part I of III, NOR Member Fred Baker By Don Velcio

Many of us know Fred Baker as a Porsche-Audi dealer from Bedford and some of us know him as a very successful auto racer. After interviewing Fred for this chapter in NOR's history, I realized that Fred Baker is the epitome of the American dream. Unlike the Earl of Grantham at Downton Abbey, Fred Baker grew up in a family of modest means in northeast England near the River Tyne. Born in the middle of World War II, Fred doesn't recall the bombings and rocket attacks on Britain as he was a baby then. But he remembers playing with his friends in bombed-out houses and buildings while growing up. (Per *Britannica*: After the war, Britain was effectively internationally bankrupt, and the economy was suffering. Virtually all goods, even bread, were rationed.) But that didn't stop Fred and his neighborhood friends from being boys. He smiles as he recounts that he loved everything with wheels, whether bicycles or homemade push carts. "Whenever you have two or more kids with toys on wheels, you had racing. And I loved to race and was most often the winner."

Fred's father was fortunate to be able to own a car and Fred helped him service the car from an early age. After graduation from high school at age 15, Fred served as an auto mechanic apprentice at a BMC dealer (Morris, Austin, MG, Riley, and more). He then moved on to a brake service specialty shop.

While working on a car brought into the brake shop by an acquaintance, Ken Davies, Fred learned that Ken was going to an interview that evening conducted by a recruiter from America. Ken invited Fred to join him there for a beer and an interview and Fred agreed. The recruiter spoke to Fred about the American dream, where Fred and his family could live in their own house and own a nice car like a VW Beetle. Fred returned home to his newlywed wife, Jayne, and announced that they were going to America. She was less than thrilled, but in October 1964 it was agreed. Soon they would be in pursuit of their dreams in Willoughby, Ohio. Chuck Stoddard had hired Fred and Ken to work at Stoddard Imported Cars.

It was early 1965 that the Bakers and the Davies (with baby) flew into New York, arriving in a snowstorm. It was snowy when they landed at Cleveland Hopkins Airport, where Chuck Stoddard arrived to pick them up. Five adults, a baby, and their luggage were crammed into a Fiat 1100 D that Chuck Stoddard drove to Willoughby. I can only imagine what the Brits thought as they drove to the heart of the snow belt during an Ohio snowstorm. Welcome to America.







At Stoddard, hard work and long hours were rewarded with a trip to Daytona Beach in September 1965. Fred and Ken crewed for Chuck who won the SCCA Runoffs (then called the American Road Race of Champions) driving an Alfa Romeo GTZ. In the accompanying picture, you can see (l-r) a 23-year-old Fred Baker, Ken Davies, and Chuck Stoddard at the Daytona International Speedway.

Fred continued to work long hours at Stoddard. After normal business hours, Fred – assisted by Mrs. Baker — helped Chuck renovate some of the thirty-six Alfas that had been water-damaged in shipping. It was dedication like this that led to Fred's promotion to Service Manager at Stoddard.
